### **PRIVACY POLICY**

This policy (together with our terms and conditions) and any other documents referred to on it) sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. ### INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following data about you:

- Information that provide filling forms you by in our site on www.janeadamsceramics.co.uk (our site). This includes information provided at the time of registering to use our site, subscribing to our service, posting material or requesting further services. #### WHERE WE STORE YOUR PERSONAL DATA

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). Such staff maybe engaged in, among other things, the fulfilment of your order, the processing of your payment details and the provision of support services. - If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms and conditions, or terms and conditions of supply and other agreements; or to protect the rights, property, or safety of J E ADAMS LTD T/A JANE ADAMS CERAMICS, our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.
